### 1. Welcome and minutes of the last meeting

#### 2. Progress with the bid for registration

The bid for registration was submitted to the Cochrane Collaboration in August 2004 and is currently with the Monitoring & Registration Group. Formal notification is likely to be in November 2004 and feedback so far has been positive. #### 3. Communication

3.1 Email list: Attendees at the meeting were informed that, if they provided an email address on the attendance sheet, they would be registered with the Cochrane IRMG mailtalk discussion list. It was confirmed that this is an open

list and all members are encouraged to post suggestions, seek partners in collaborative ventures etc.

3.2 Website: Thanks were expressed to Yngve Falck-Ytter and Dave Booker of the German Cochrane Centre for establishing a web-page for the group & to Yngve for offering to manage the site for the time being. The minutes of this and future meetings and the current module would be circulated via the email list and posted onto the web site as soon as possible after the meeting.

3.3 Links with other groups: It was confirmed that updates on the progress of the Group would also be shared with other relevant Cochrane entities, the Campbell IRMG and other organisations (as listed in the current module) to share information and encourage collaboration.

#### 4. Workplan

Although a workplan for the Group would not be agreed pre-registration, a number of relevant ongoing projects were brought to the Group's attention.

4.1 Description of search strategies in the Cochrane Reviewers' Handbook: Work is required to update Chapter Five of the Cochrane Reviewers' Handbook in collaboration with the Cochrane CENTRAL Advisory Group, particularly the guidance on search strategies. The Special Interest Group on Information Retrieval of Health Technology Assessment international have expressed an interest in working jointly with the Cochrane IRMG and the Information Specialists Sub-group of InterTASC, the UK-based group which works on technology assessment reports for the National Institute for Clinical Excellence (NICE) in the UK would also like to join the collaboration. 4.2 Indexing policies in databases of relevance to public health: A web-site is available free-of-charge on the web with details of subject headings in databases (23 to date) describing specific research types (reviews, trials, observational, qualitative etc.) and the results from a range of relevant text words. Collaboration is welcomed from other information searchers who might like to use the information to explore indexing policies and search strategy developments. Web site address:

4.3 Other relevant projects: Margaret Sampson is seeking collaborators to look in more detail at the indexing of the randomized controlled trials (RCTs) indexed in MEDLINE and EMBASE. In particular, were the trials appropriately tagged, such as with Randomized Controlled Trial [publication type] in MEDLINE? It is suggested that further research is needed on the accuracy and completeness of

this tagging over time and across disciplines. It was agreed that Margaret's original proposal would be re-circulated to the email list for information once all attendees to the meeting had been included. For more information contact <u>msampson@cheo.on.ca</u>.

#### 5. New ideas for projects

5.1 Follow up of registered trials to see if they have been published within five years. Carol L informed the group that a document is being drawn up within the Cochrane Collaboration addressing the issue of registration of trials at inception and the possible penalties of not doing so, such as refusal of the journal publishers to publish the results in high impact-factor journals.

5.1 Peer reviewing of search strategies and an analysis of the methodological strategies produced by McMaster and other organisations. It was agreed that this project would be carried forward within the work identified in 4.1

5.3 Ruth Foxlee would welcome collaboration on the development of diagnostic test accuracy filters with sensitivity/precision measures. It was noted that relevant work is ongoing at the University of York's Centre for Reviews & Dissemination (CRD).
