## **Update Report January 2020**

## Chair and convenors update

Following the announcement that Luke Vale would be stepping down as chair (lead) convenor a process to identify a new lead has been followed. Progress with this is outlined in the attached in the document below. Denny John (current convenor) has been nominated to take over the lead role. At present we are awaiting feedback from the Cochrane Methods Executive that this change is acceptable. Campbell appear happy with this change.



Following the September meeting Ian Shemilt also announced his intention to step down as a convenor. This will occur either after Luke Vale has stepped step down or once the process to identify and elect a new Lead Convenor of the CCEMG has been agreed, whichever happens latest. It would be for new Lead convenor and convenor group to decide how whether Ian will be replaced as a convenor following any decisions about the governance and structure of the group that are made.

## Administrative support for the CCEMG

It has been confirmed support for the methods group currently leveraged from within the Health Economics and Evidence Synthesis Groups at Newcastle University will continue. Discussions will be held between the Newcastle University based members of staff and the new lead as to how this might operate.
