#### Overall study protocol

The overall study protocol was submitted for publication in Systematic Reviews; thanks to all for your comments and feedback in shaping the final submission.

### Systematic reviews update

Drafts of the 4 systematic review protocols have been circulated to members who expressed interest in contributing to specific reviews and we are in the process of incorporating feedbacks. We expect these to be submitted to Campbell by the end of November 2019. Screening and tagging are completed and data extraction will begin in October. A project overview and details on the reviews and how to get more involved are attached.

Please note that we want to include everyone who makes a substantive contribution as a co-author on these reviews and other planned papers for the project. Co-authors must meet the ICJME criteria for authorship. This means, in addition to commenting on the draft reviews, you would need to participate in one of the following: screening for studies to include in the reviews, data extraction from the studies identified as meeting inclusion criteria (using a pretested form), data analysis or interpretation of the results from the included studies, or other tasks. Team members who don't meet all criteria may be acknowledged as members of the MuSE Working Group.

### **MUSE Patient Reference Group**

We have engaged Sophie Staniszewska (UK) in the development of the MuSE stakeholder engagement evaluation framework. The objective of the evaluation framework will be to assess the processes and impact of the MuSE study's engagement of its own multiple stakeholders throughout the four-year study.
